

MESQUITE SHOOTERS PISTOL CLUB RANGE SAFETY RULES

1. The use of alcohol prior to or during shooting events is prohibited. Violation will result in immediate expulsion from the club.
2. Hearing, suitable eye protection and brimmed hat are required.
3. The range is a cold range. No pistol may be loaded except when on the firing line at the specific instruction of the Range Safety Officer (RSO) or Range Master.
4. Muzzles will always be pointed in a safe direction - down range. Never point a weapon at something you are not willing to put a hole in.
5. Movement to and from the firing line will be with the action open, muzzle elevated and down range and finger out of the trigger guard or holstered in an approved holster.
6. When on the firing line, keep your finger off the trigger until you are aligned on the target.
7. On the firing line, listen to and obey all directions of the RSO.
8. The RSO will use a whistle as the Safety Alert System. At the sound of the whistle, immediately stop shooting, remove your finger from the trigger guard and listen for the RSO's instructions.
9. The decisions of the RSO concerning safety are not to be questioned, his word is final and there is no appeal.
10. The following safety violations result in immediate expulsion from the match and special safety instruction from the Range Master to prevent recurrence: Failing to maintain a safe muzzle direction, failing to maintain control of your weapon, failing to heed the directions of the RSO.
11. Holsters shall cover the trigger guard and retain the pistol while moving including running and jumping. The use of USPSA, IDPA, and/or IPSC approved holsters is encouraged.

RELEASE FROM RESPONSIBILITY FOR PARTICIPATION IN
DANGEROUS ACTIVITY**

In consideration for the use of the Mesquite Police shooting range and the Mesquite Shooters Pistol Club and the use of firearms on those premises which Releasor expressly recognizes to be a dangerous activity, Releasor, for him or herself, his or her spouse, legal representative, heirs and assigns, hereby releases, waives and discharges the Mesquite Shooters Pistol Club in its officers and members, owners, and officers and employees, referred to as Releasees, from all liability to Releasor, his or her spouse, legal representative, heirs and assigns for any and all loss and damage, and any claim of damages resulting therefrom, on account of injury to Releasor's person or property, even injuries resulting in death of the Releasor, whether caused by negligence of Releasees or otherwise while Releasor is using the premises or facilities of the Releasees.

Releasor agrees to indemnify the Releasees and each of them, from any loss, liability, damage, or cost they may incur due to the presence of Releasor in or upon the premises and facilities of Releasees, whether caused by negligence of Releasee or otherwise.

Releasor hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of Releasee or otherwise, while upon and using the premises and facilities of Releasees and while competing, officiating, working, or for any purpose participating in any events on the premises and facilities of Releasee.

Releasor expressly agrees that this release, waiver and Indemnity agreement is intended to be as broad and inclusive as permitted by the State of Nevada, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.

Releasor hereby represents that he/she is knowledgeable in Basic Firearms Safety and above Range Safety Rules.

This contract provides only for the use of the facilities of the Mesquite Shooters Pistol Club. It confers no rights in or control over the facilities and operation of the Mesquite Shooters Pistol Club.

All releases for persons under the age of 18 years old must be executed by that person's parent or court appointed guardian.
